“A RESOLUTION PROPOSING TO THE UN GENERAL ASSEMBLY TO DECLARE 2010-2020 as INTERNATIONAL RECONCILIATION DECADE in furtherance of the 2009 International Reconciliation Year Proclamation.”

WHEREAS, the UN Charter, embodying its purposes and principles, is duty-bound to protect future generations from the scourge of war, through peaceful means, and in conformity with the principle of justice and international rule of law, shall adjust or settle disputes or conflict situations, by practicing tolerance and friendly and brotherly relations among men and nations, shall promote global cooperation in resolving social, economic, political and cultural issues.

WHEREAS, the UN General Assembly on November 2006, proclaiming 2009 as International Reconciliation Year, asserted among others: “Reconciliation processes are particularly necessary and urgent in countries and regions of the world which have suffered or are suffering situations of conflict which have affected and divided societies in their various internal, national and international facets.”

WHEREAS, conflicts transcend national borders and requires global solutions, whereby national, regional and international civil organizations - including individuals, play vital role in the reconciliation processes towards sustainable peace and order.

WHEREAS, Reconciliation is a magnanimous form of peacekeeping dialogue, that has historical and traditional humanistic roots in various cultures and civilizations, which then and now enhanced respect and tolerance interdisciplinary and complementary values, reconciled individual relationships, family ties, tribal and national communities, regional and international relations.

WHEREFOR, Reconciliation shall serve as the heart within which the United Nations (UN) as the epitome of the Family of Nations, in up-grading its peace-building activities, conflict prevention programs, nuclear disarmament initiatives, in pursuing sustainable development

plans envisioned under the Eight (8) MDGs: health and environmental protection, eradication of poverty and violation of human rights, the rule of law and ethical governance.

FURTHER ON, during the Reconciliation Decade, unfinished, abandoned or previously unresolved, issues can be further pursued, new structural innovations in governance, organizational and personal, shall be put into place, during which time foster patience, knowledgeable high-mindedness and unwavering resolved in the conduct of public affairs.

NOW, THEREFORE, by virtue of the above-mentioned reasons, it is hereby resolved, as it is herewith PROPOSED, that the UN GENERAL ASSEMBLY, shall PROCLAIM 2010-2020 AS RECONCILIATION DECADE, in pursuance of its November 2006 Proclamation declaring 2009 as International Reconciliation Year.
